

### **Direct Entry Terms and Conditions**

Effective: 01 April 2025

#### UK

- 1. All payments are made at the discretion of the relevant Partner university
- 2. Commission is paid on a % of tuition fees only minus any institutional aid (i.e. net tuition), and is subject to final validation from University Partners
- 3. Commission will be paid for EU students at all Partner Universities (EU students who are assessed as overseas for fee purposes)
- 4. Commission will be paid for PhD enrolments at all Partner Universities

#### US

The following are true across all partners, unless specified in the Centre-specific Terms & Conditions.

#### Eligibility

- 1. INTO University Partnerships will only pay commission on a student's matriculation to their first degree at the University.
- 2. US citizens/permanent residents are not eligible for commission. Universities may also exclude additional visa types or student enrolment types from commission eligibility.
- 3. Please ensure that you retain student visa copies and university ID numbers to support commission queries.
- 2. For applications submitted to the University directly and where a Direct Entry Waiver (DEW) form is required:
  - The DEW form must be completed within 15 days of application submission. Failure to do so may impact on commission payments.
  - The student name, email address and date of birth on the DEW form must match those on the university application.
- 3. For institutions that do not accept Direct Entry Waiver (DEW) Forms, the following precedence rules apply:
  - If multiple applications are received by the university, the application with the earliest submission date will be prioritized.
  - If the INTO application is not received first, it may be canceled, and commission may not be payable.
- 4. The following enrolment types are not eligible for commission unless specified in Centre-specific Terms & Conditions.
  - PhD students (see GMU and SLU exceptions)
  - Summer semester enrolments commission is not due against summer semester enrolments (see UoA and NEC exceptions). Where eligible, commission will be calculated as the student's first semester of enrolment and payable alongside commission for Fall enrolments.
  - Student athletes for applicants who join athletic programs, eligibility is determined by each partner and their governing athletic association.

#### Calculation and Payment

- Commission is calculated based on the number of credit hours taken in the first two commissionable semesters of a student's study plan. A variance in the number of credit hours taken may impact commission calculations. This could mean that commission amounts for semesters one and two differ in value.
- 2. Agent commission will be payable in line with communicated commission payment timelines on a semester basis in two instalments of 50% for up to two semesters, unless otherwise agreed.
- 3. Where students have outstanding tuition fees with universities, commission will not be paid or may be paid at a lower level where partial tuition fees are paid.
- 4. University partners will only allow reconciliation of unpaid tuition fees twice. Should a student continue to have outstanding tuition fees during the second reconciliation, commission will not be paid or may be paid at a lower value where partial tuition fees are paid.
- 5. All payments are made at the discretion of and subject to final validation from University Partners.

- DEW forms are not accepted for undergraduate students. All applications must be submitted through Partner Portal.
- For graduate applications, the drop-down option for Global INTO Intl Partner Agent under the Sponsor or Program Affiliation field must be completed correctly in order for students to be commissionable through INTO and a DEW form must be submitted.
- If a graduate application is submitted by the student and Global INTO Intl Partner Agent is not selected from the dropdown menu at that time, the following university form can be completed to add the INTO tag. This must be completed within 30 days of application submission and 'INTO' must be noted in the Partner/Agency Name field:
